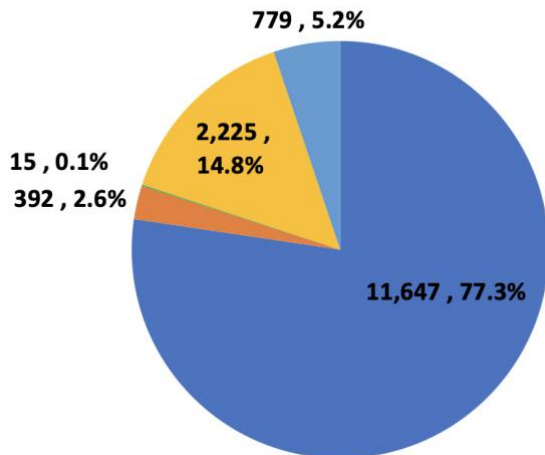


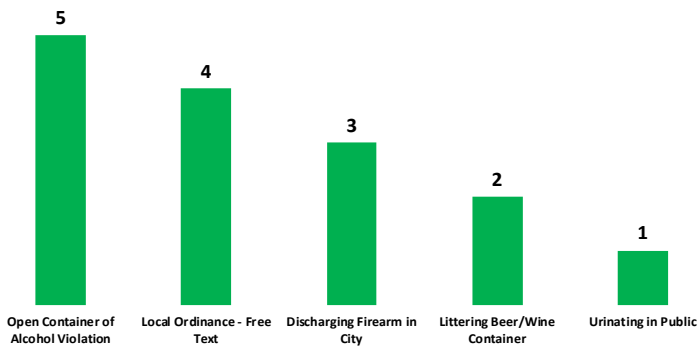
77.3% of Columbus County misdemeanor charges were for nonviolent and non-DWI related traffic offenses, 14.8% were for other nonviolent offenses, 2.6% were for DWI and related offenses, 5.2% were for violent offenses, and .1% were for nonviolent ordinance violations.

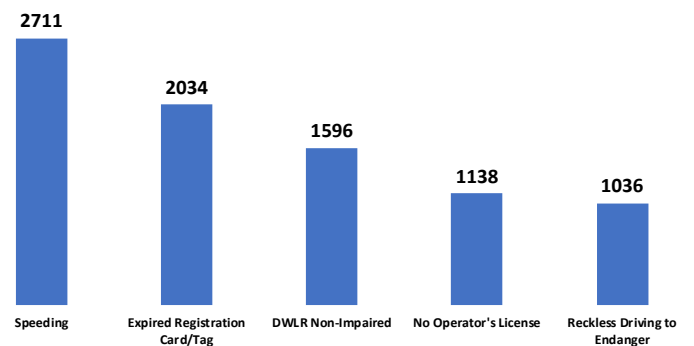

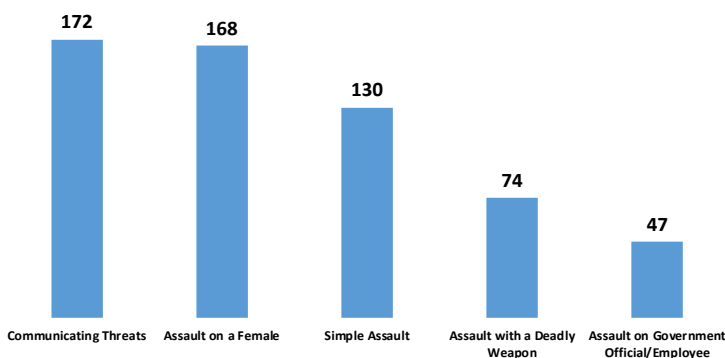
Most Commonly Charged Ordinance Violations



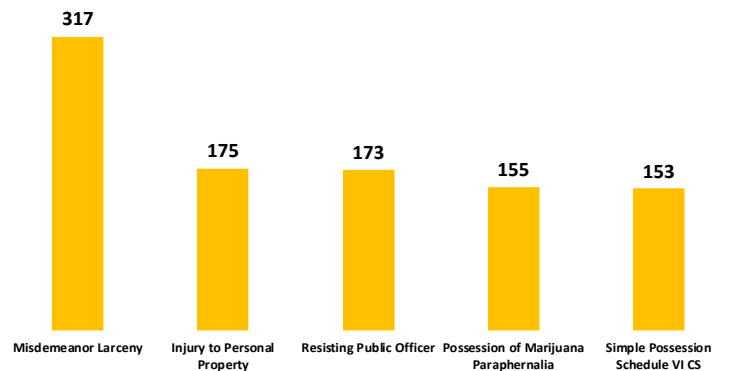
Most Commonly Charged Non-DWI Related Traffic Misdemeanors



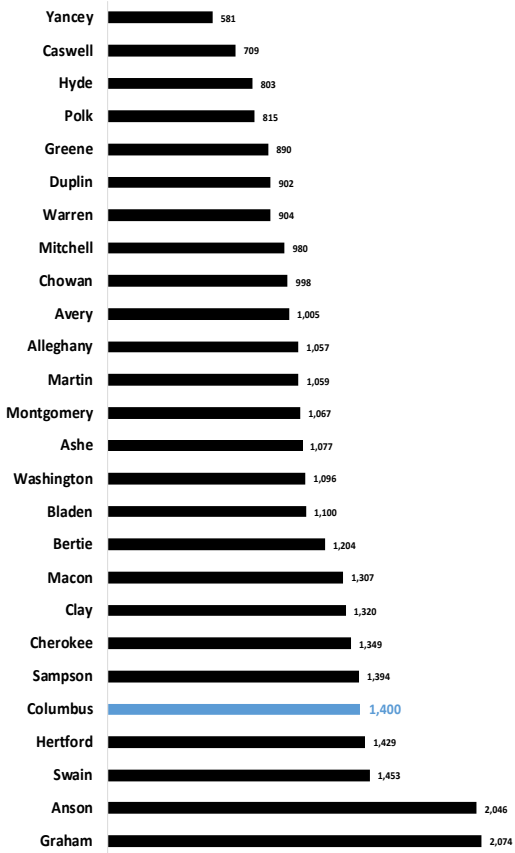
Most Commonly Charged Violent Misdemeanors



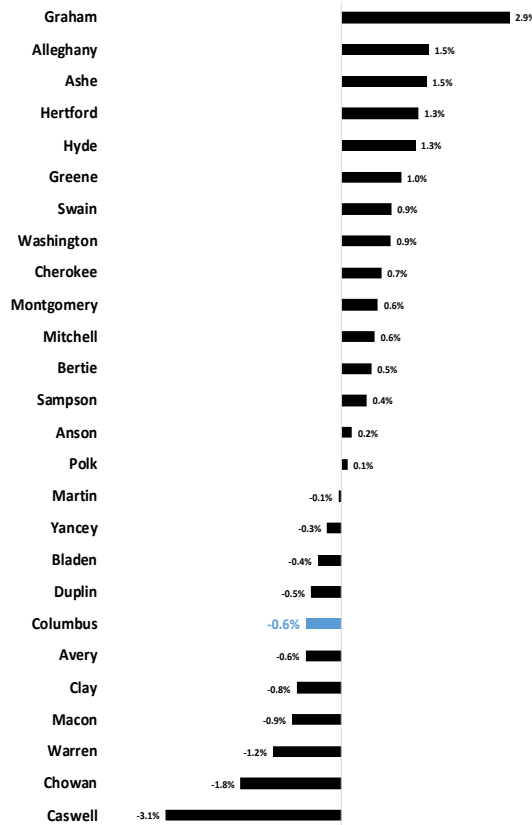
Most Commonly Charged Other Nonviolent Misdemeanors



2019 Violent Misdemeanor Charges Per 100,000 Population Among Noncore Counties

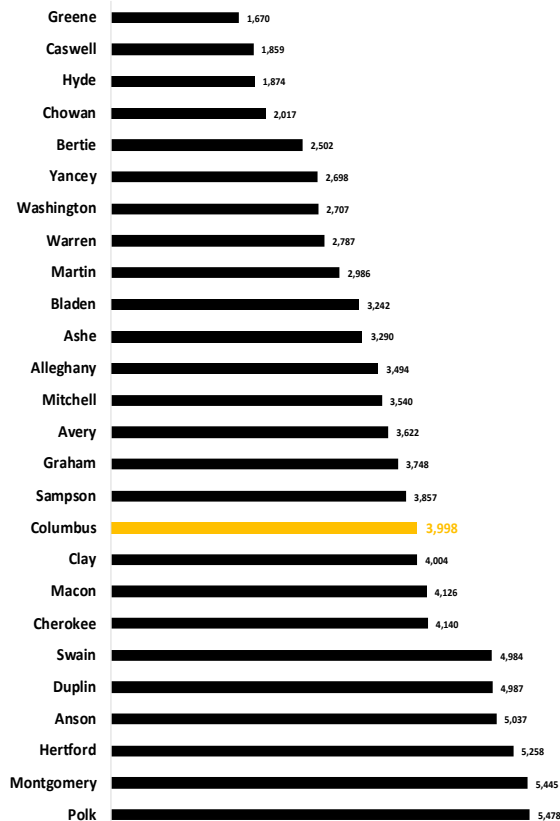


2018 - 2019 Change in Percentage Violent Misdemeanor Charges Among Noncore Counties

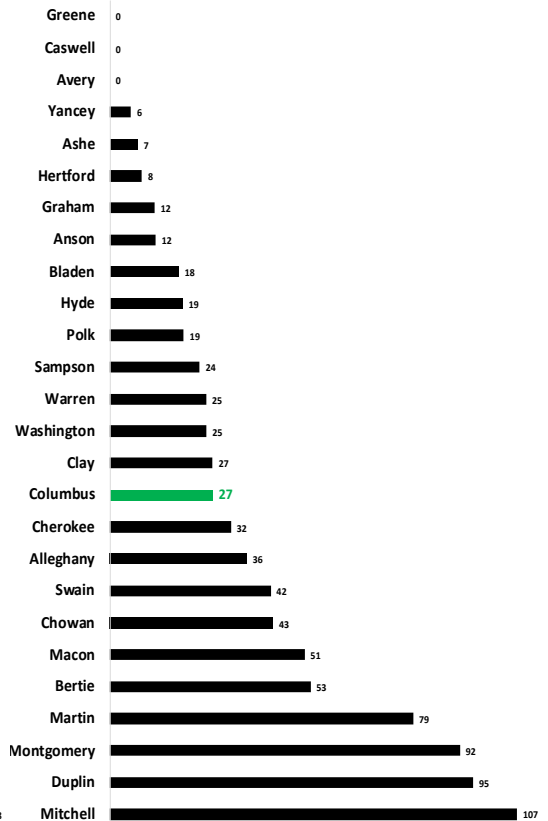


Among noncore counties¹, Columbus County had the fifth highest number of violent misdemeanor charges per 100,000 residents in 2019 at **1,400**. Between 2018 and 2019, Columbus County had the seventh largest decrease in violent misdemeanor charges among noncore counties at **.6** percentage points.

2019 Ordinance Violation Charges Per 100,000 Population Among Noncore Counties

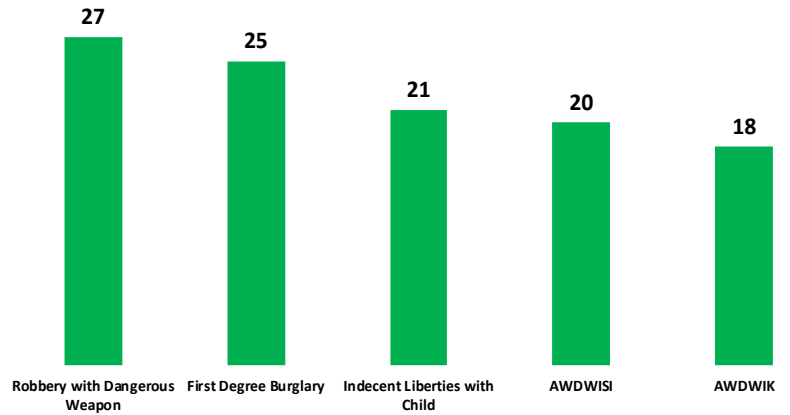


Among noncore counties¹, Columbus County had the 10th highest number of other nonviolent misdemeanor charges per 100,000 residents in 2019 at **3,998**. Columbus County had the 11th highest number of ordinance violation charges per 100,000 residents in 2019 at **27**.

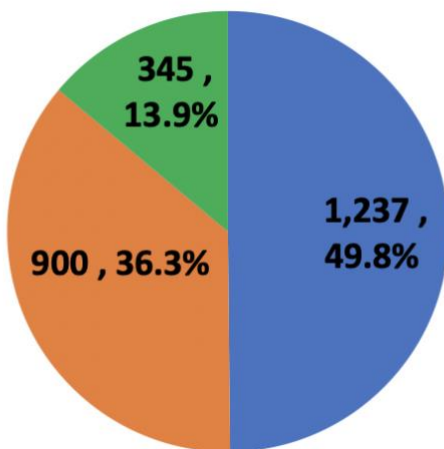

13.9% of Clay County felony charges were for violent felonies, **36.3%** were for nonviolent drug felonies, and **49.8%** were for other nonviolent felonies.

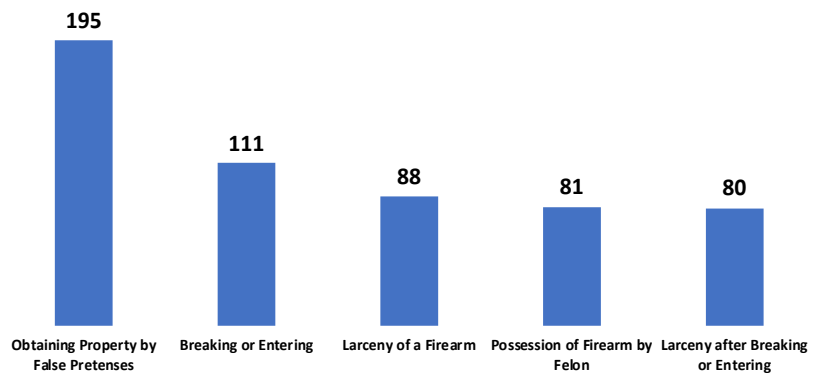
Most Commonly Charged Violent Felonies



2019 Charged Felonies

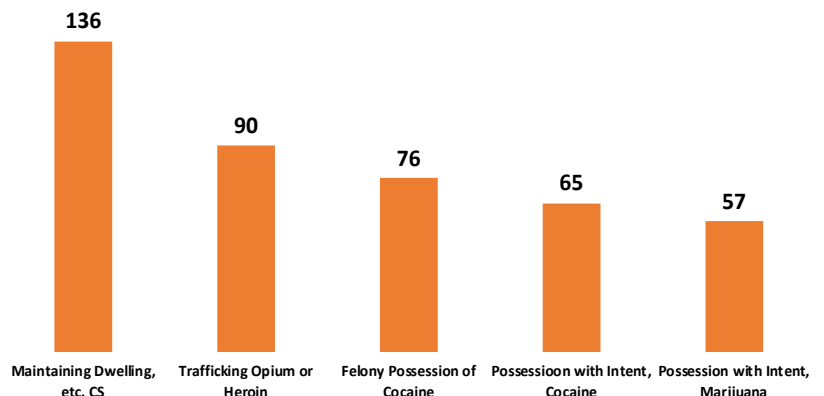


Most Commonly Charged Other Nonviolent Felonies



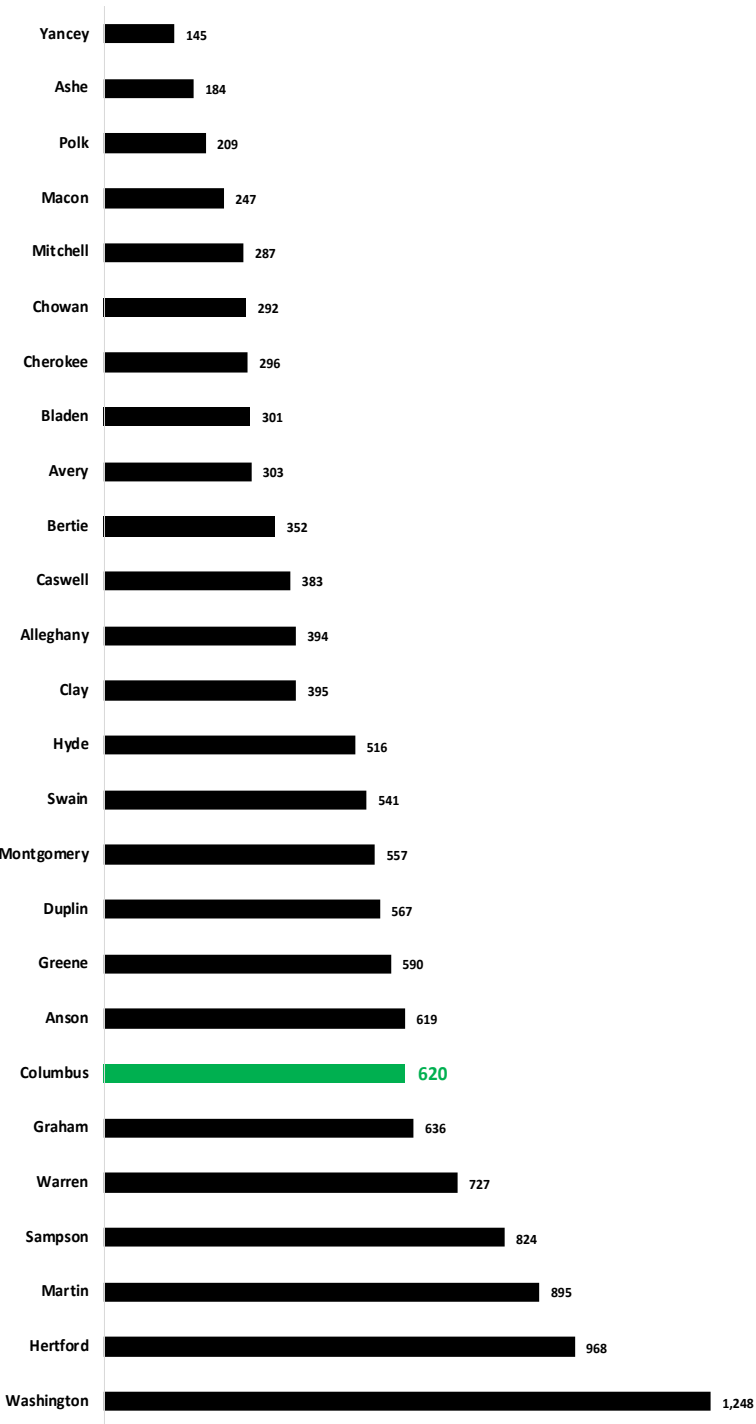

Most Commonly Charged Drug Felonies

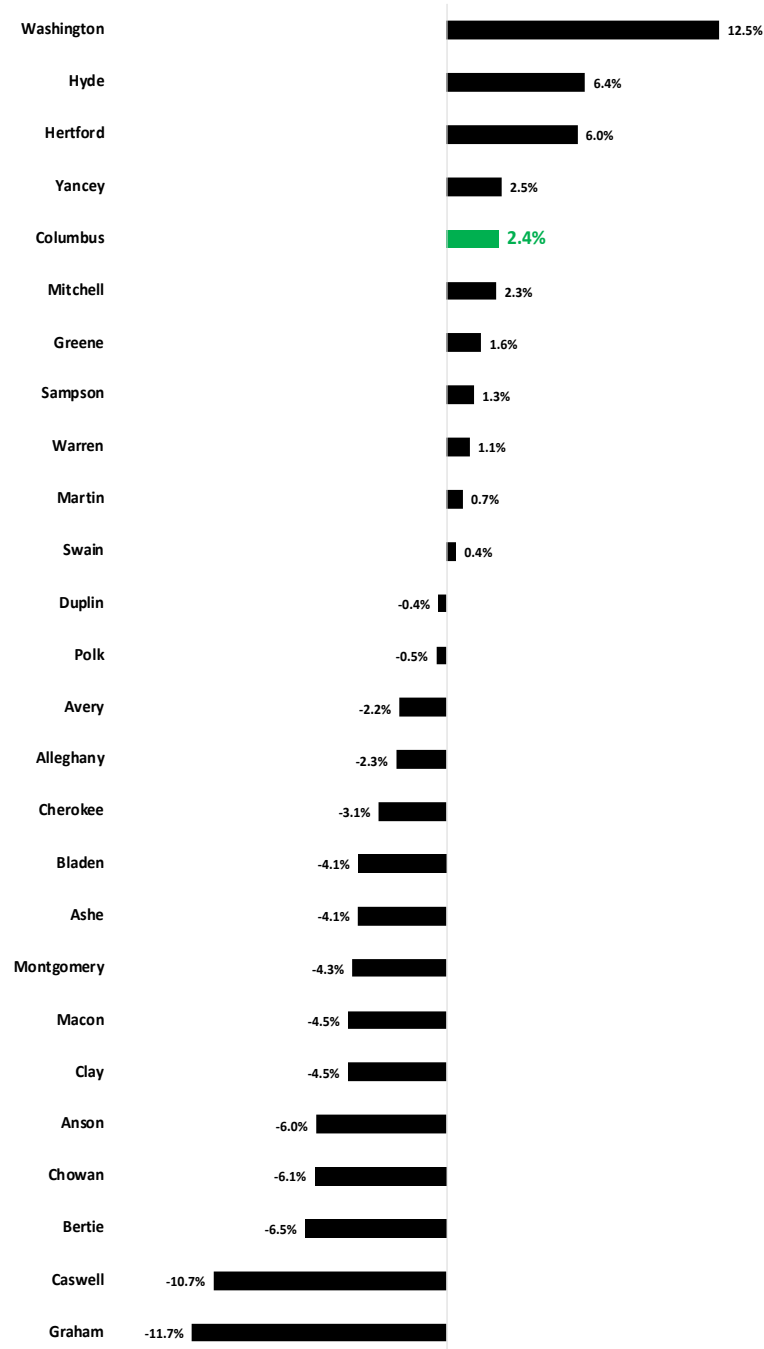


Among noncore counties¹, Columbus County had the seventh highest number of violent felony charges per 100,000 residents in 2019 at **620**. Between 2018 and 2019, Columbus County had the fifth largest increase in violent felony charges among noncore counties at **2.4** percentage points.
