















Most Commonly Charged Ordinance Violations



2019 Violent Misdemeanor Charges Per 100,000 Population Among Medium Metro Counties




Among medium metro counties¹, **Durham County had** the 11th lowest number of violent misdemeanor charges per 100,000 residents in 2019 at 1.014. Between 2018 and 2019, Durham County had the seventh largest decrease in violent misdemeanor charges among medium metro counties at .8 percentage points.









Among medium metro counties¹, Durham County had the 11th highest number of violent felony charges per 100,000 residents in 2019 at **505**. Between 2018 and 2019, Durham County had the fifth largest decrease in violent felony charges among medium metro counties at **3.2** percentage points.
