




66.8% of Iredell County misdemeanor charges were for nonviolent and non-DWI related traffic offenses, 24.0% were for other nonviolent offenses, 4.0% were for DWI and related offenses, 5.1% were for violent offenses, and 0.2% were for nonviolent ordinance violations.
















Most Commonly Charged Other Nonviolent Misdemeanors






Among large central and large fringe metro counties^{1,2}, Iredell County had the sixth highest number of violent misdemeanor charges per 100,000 residents in 2019 at **865**. Between 2018 and 2019, Iredell County had the sixth largest decrease in violent misdemeanor charges among medium metro counties at .3 percentage points.

Among large central and large fringe metro counties^{1,2}, Iredell County had the second highest number of other nonviolent misdemeanor charges per 100,000 residents in 2019 at 4,099. Iredell County had the sixth lowest number of ordinance violation charges per 100,000 residents in 2019 at 28.








16.4% of Iredell County felony charges were for violent felonies, 38.9% were for nonviolent drug felonies, and 44.7% were for other nonviolent felonies.




2019 Charged Felonies






- Nonviolent Felonies, Other

Among large central metro counties¹ and large fringe metro counties², Iredell County had the second highest number of violent felony charges per 100,000 residents in 2019 at 589. Between 2018 and 2019, Iredell County had the largest decrease in violent felony charges at 6.2 percentage points.
