



68.7% of Lincoln County misdemeanor charges were for nonviolent and non-DWI related traffic offenses, **18.9%** were for other nonviolent offenses, **5.4%** were for DWI and related offenses, **6.8%** were for violent offenses, and **0.1%** were for nonviolent ordinance violations.




Most Commonly Charged Violent Misdemeanors




Most Commonly Charged Non-DWI Related Traffic Misdemeanors




Most Commonly Charged Ordinance Violations




Most Commonly Charged Other Nonviolent Misdemeanors






Among large central and large fringe metro counties^{1,2}, Lincoln County had the second highest number of violent misdemeanor charges per 100,000 residents in 2019 at **1,061**. Between 2018 and 2019, Lincoln County had the fifth largest decrease in violent misdemeanor charges among medium metro counties at .3 percentage points.

Among large central and large fringe metro counties^{1,2}, Lincoln County had the fifth highest number of other nonviolent misdemeanor charges per 100,000 residents in 2019 at 2,940. Lincoln County had the third lowest number of ordinance violation charges per 100,000 residents in 2019 at 11.






10.7% of Lincoln County felony charges were for violent felonies, 37.0% were for nonviolent drug felonies, and 52.3% were for other nonviolent felonies.



2019 Charged Felonies




Most Commonly Charged Drug Felonies




- Nonviolent Felonies, Other

Most Commonly Charged Other Nonviolent Felonies



Among large central metro counties¹ and large fringe metro counties², Lincoln County had the sixth highest number of violent felony charges per 100,000 residents in 2019 at 439. Between 2018 and 2019, Lincoln County had the eighth largest increase in violent felony charges at .1 percentage points.
