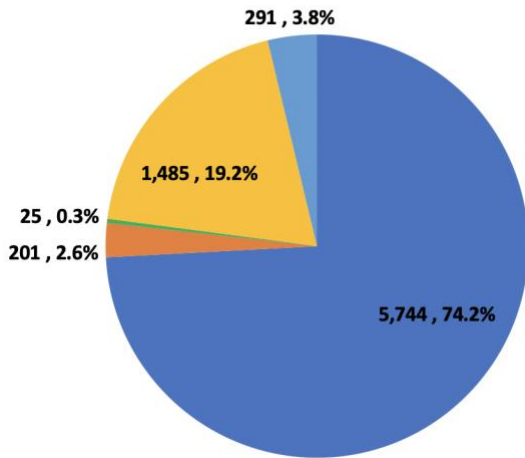


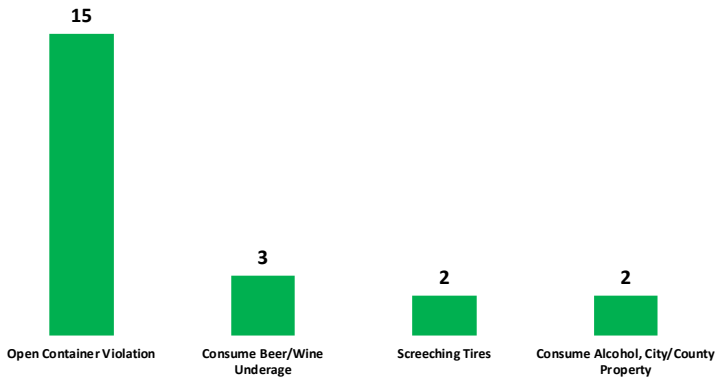
74.2% of Montgomery County misdemeanor charges were for nonviolent and non-DWI related traffic offenses, 19.2% were for other nonviolent offenses, 2.6% were for DWI and related offenses, 3.8% were for violent offenses, and 0.3% were for nonviolent ordinance violations.

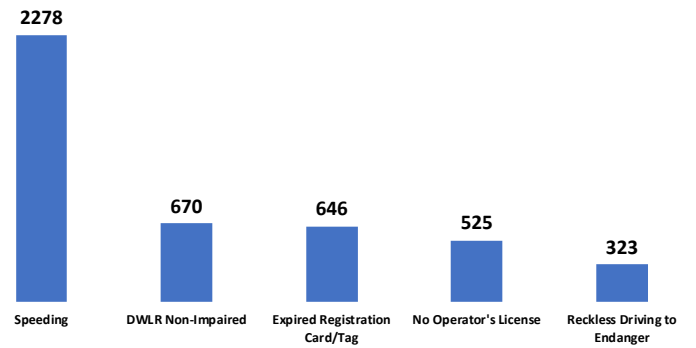

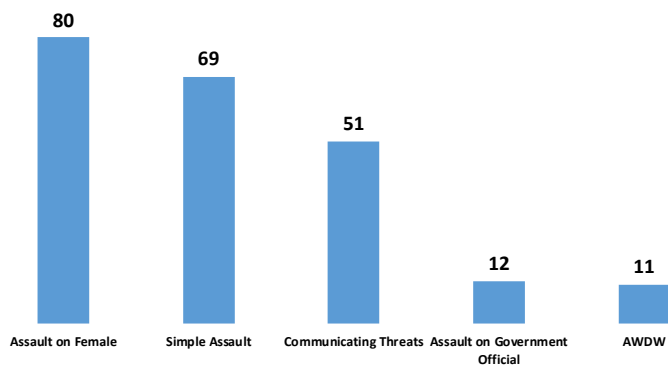
#### Most Commonly Charged Ordinance Violations



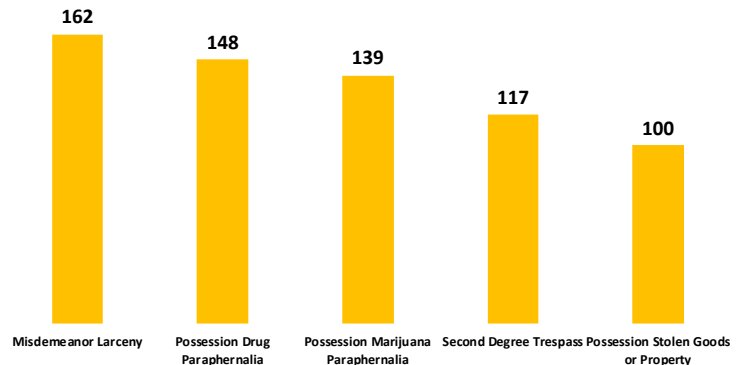
#### Most Commonly Charged Non-DWI Related Traffic Misdemeanors



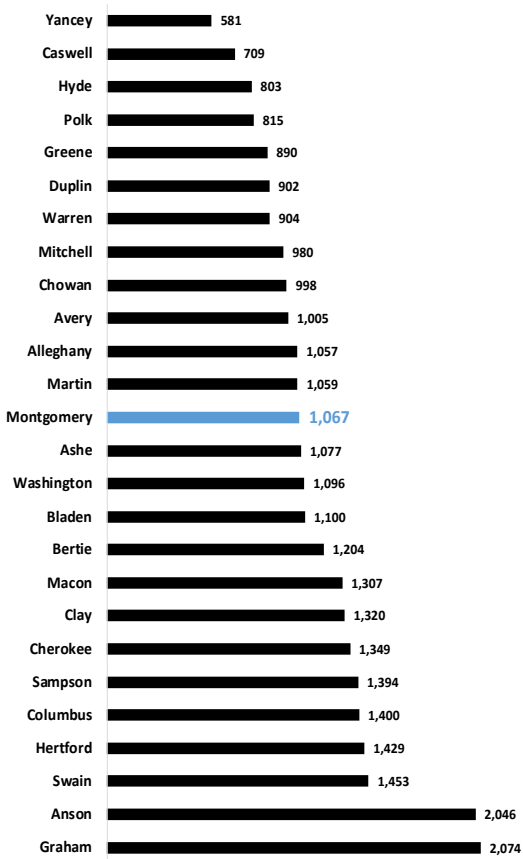
#### Most Commonly Charged Violent Misdemeanors



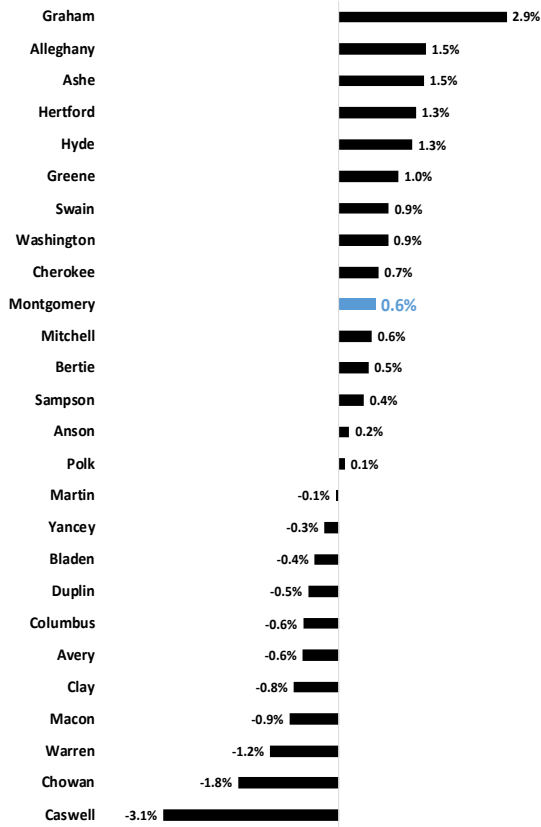
#### Most Commonly Charged Other Nonviolent Misdemeanors



2019 Violent Misdemeanor Charges Per 100,000 Population Among Noncore Counties

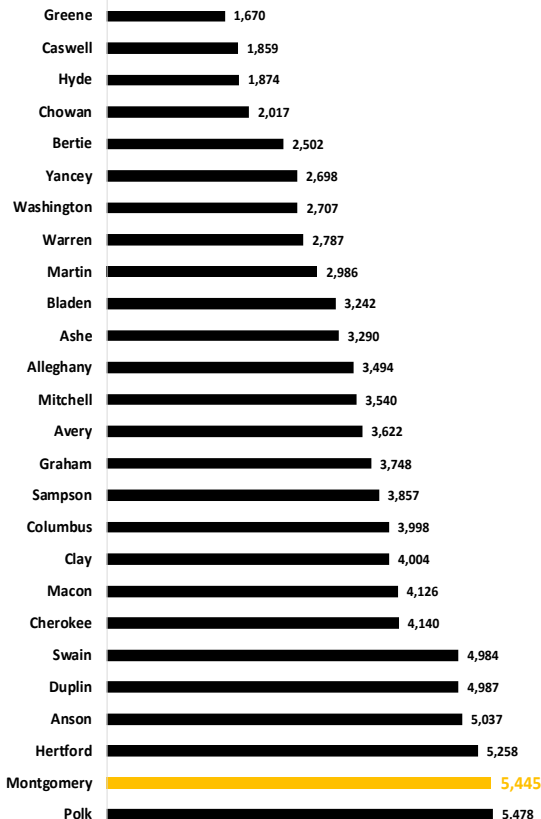


2018 - 2019 Change in Percentage Violent Misdemeanor Charges Among Noncore Counties

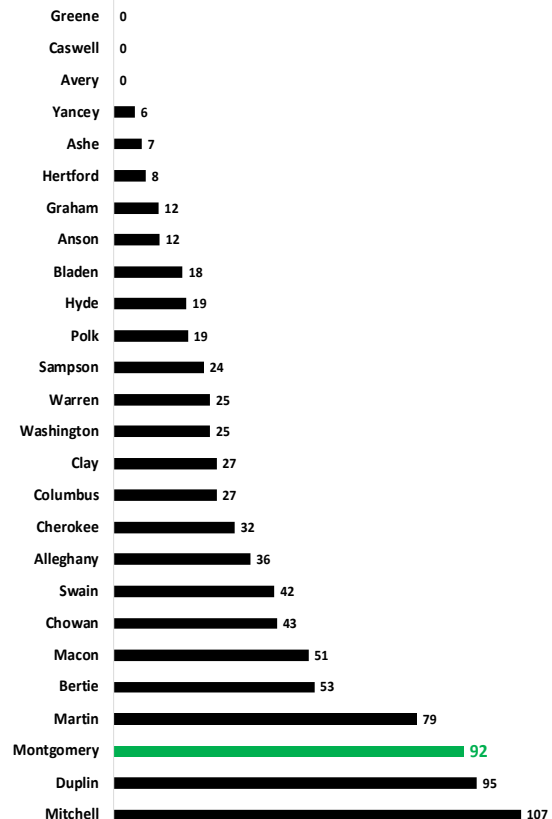


Among noncore counties<sup>1</sup>, Montgomery County had the 13<sup>th</sup> highest number of violent misdemeanor charges per 100,000 residents in 2019 at **1,067**. Between 2018 and 2019, Montgomery County had the 10<sup>th</sup> largest increase in violent misdemeanor charges among noncore counties at **.6** percentage points.

2019 Ordinance Violation Charges Per 100,000 Population Among Noncore Counties

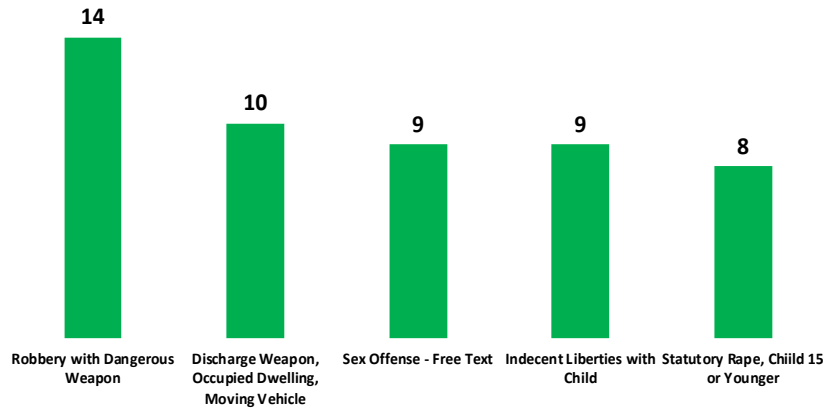


Among noncore counties<sup>1</sup>, Montgomery County had the second highest number of other nonviolent misdemeanor charges per 100,000 residents in 2019 at **5,445**. Montgomery County had the third highest number of ordinance violation charges per 100,000 residents in 2019 at **92**.

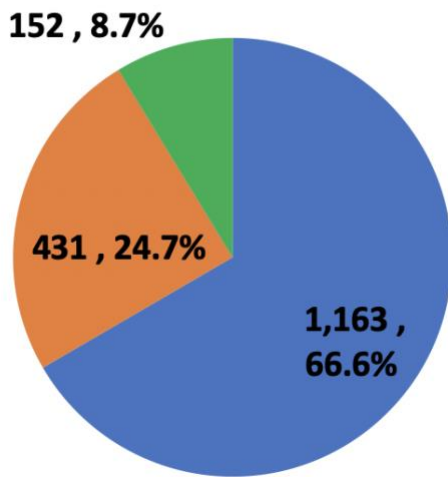

Most Commonly Charged Violent Felonies

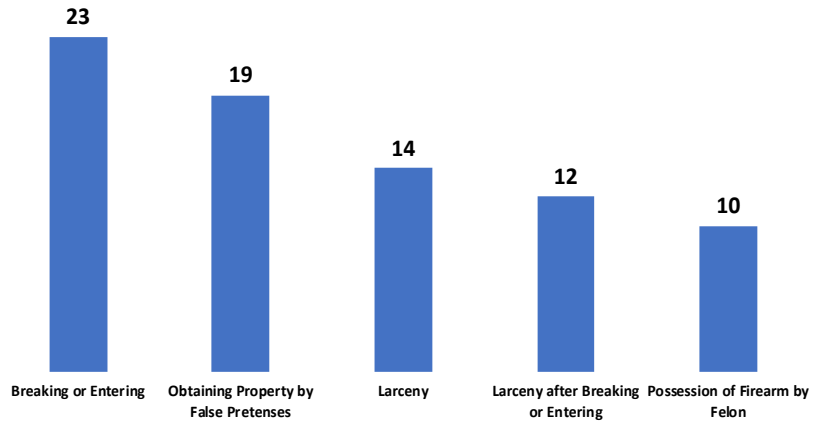

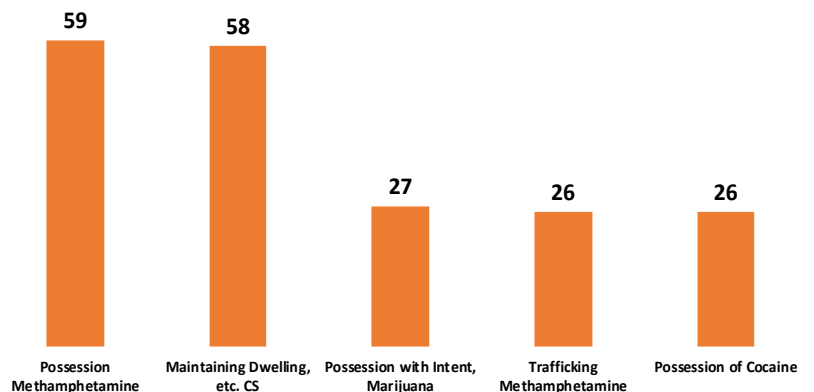

Most Commonly Charged Drug Felonies

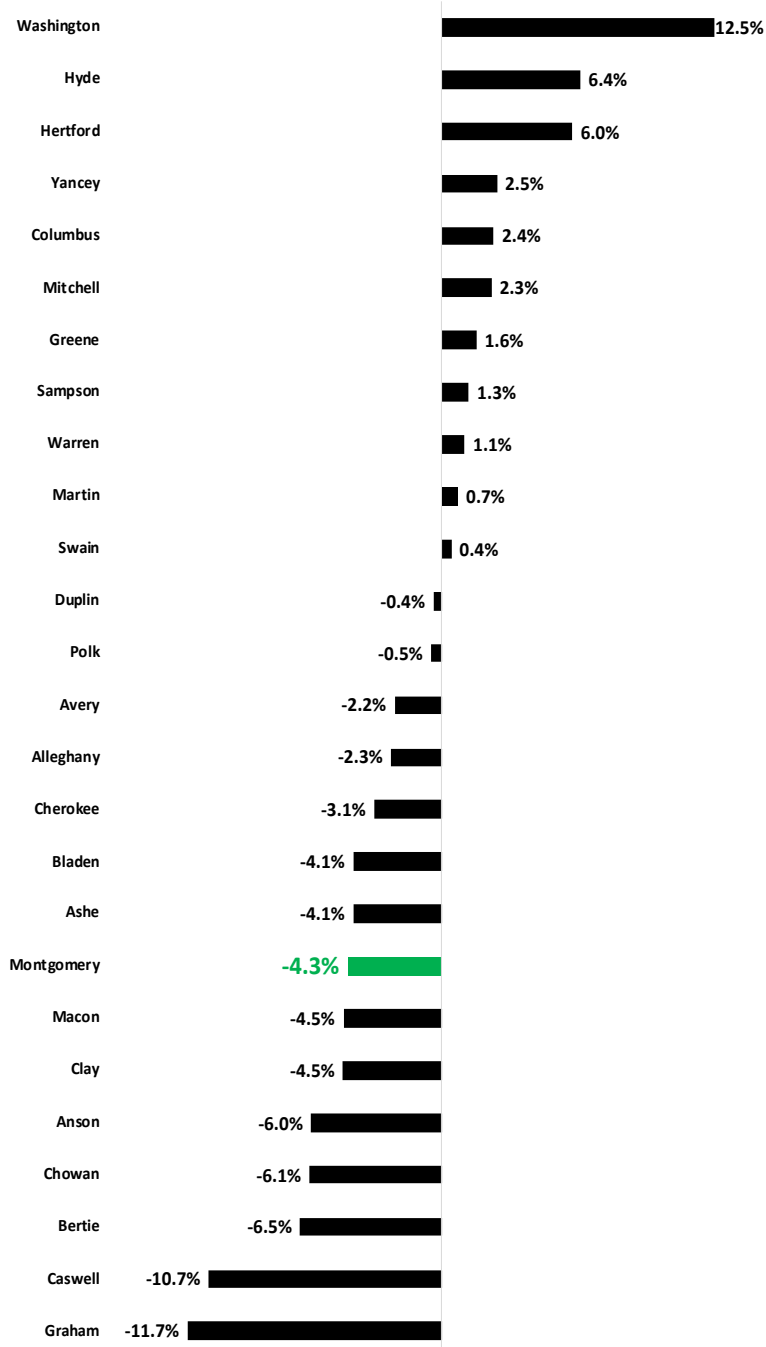


Among noncore counties<sup>1</sup>, Montgomery County had the 11<sup>th</sup> highest number of violent felony charges per 100,000 residents in 2019 at **557**. Between 2018 and 2019, Montgomery County had the eighth largest decrease in violent felony charges among noncore counties at **4.3** percentage points.
